Eligibility:

Purchasers must not include the name of anyone under the age of 18 on the ticket due to the requirements of the Public Trustee Act.

Tickets may only be purchased or sold in Alberta.

Contest guidelines prohibit the following people from purchasing tickets in the lottery: Executive members of the Covenant Foundation's Board of Trustees & Governors; employees of the Covenant Foundation, staff of Stride Management Corp, staff of Calder Bateman Communications Ltd.; and their immediate family members.

Purchasers are not required to purchase a ticket in the DreamLife Lottery or the Split 50 Lottery to be eligible to purchase tickets in the 12 Days Lottery. However, ticket purchasers who only purchase 12 Days Lottery tickets and not the DreamLife Lottery tickets or the Split 50 Lottery tickets will only be eligible for the 12 Days draw being held on Friday, November 9, 2018.

Draw Dates:

The 12 Days draw will be held on Friday, November 9, 2018, at the Grand Prize Show Home, 5530 Chegwin Point, Edmonton, AB, starting at 10:00 AM. with the lowest value prizes drawn first: \$10,000 cash prizes; then \$25,000 cash prizes; then the \$100,000 cash prize. Twelve (12) draws will be conducted. After each draw by numbered ticket stub, the winner will be recorded and the ticket stub placed back in the drum for the next draw. Each ticket is eligible for all prizes. Only tickets purchased before the 12 Days Lottery cutoff of Midnight on Thursday, October 18, 2018, will be eligible for this draw.

If all tickets are sold by Thursday, September 27, 2018, on approval of Alberta Gaming & Liquor Commission, all prizes will be drawn commencing Thursday, October 18, 2018, at 10:00 AM until finished. All draws will be held at the Grand Prize Show Home, 5530 Chegwin Point, Edmonton, AB.

Winners will be announced daily from December 13, 2018 through until December 24, 2018.

The winner will be notified in writing by Stride Management Corp. detailing what they have won and where they can claim their prize. Also, the name, city and winning ticket number of the winner may be published on the lottery website site www.dreamlifelottery.win and on social media.

The above-mentioned draw is open to any member of the general public wishing to attend.

If any purchased ticket has been entered for any draw, no refund will be issued.

Prize:

Prizes must be accepted as awarded and must be claimed by November 9, 2019. If any prize remains unclaimed for more than 1 year from the date of the draw, a request will be made to Alberta Gaming & Liquor Commission for a decision regarding the disbursement of the prize.

Retail value of the prizes is **\$240,000.00** (includes GST). Breakdown is as follows:

- Nine cash prizes of \$10,000 on December 13 - 21, 2018.
- Two cash prizes of \$25,000 on December 22 & 23, 2018, and
- One cash prizes of \$100,000 on December 24, 2018.

Tickets:

In the event that a ticket lists more than one name, the Licensee will award the prize to the individual whose name appears first on the stub. The Licensee and the Alberta Gaming & Liquor Commission are not responsible for resolving any disputes that may arise between the different individuals.

All sets of multiple tickets must contain the same information.

All tickets will be controlled by Stride Management Corp. and are only available online, by phone, mail, the Grand Prize Dream Home and participating hospital kiosks.

Tickets may be purchased with VISA, MasterCard, American Express, bank debit card, cash, cheque, and money order. The Lottery's liability is limited to the purchase price of the ticket.

12 Days tickets available are; 9,618 single tickets at \$20 each, 7,557 sets of 5 for \$50 and 5,725 sets of 15 for \$75 for a total of 133,278 tickets.
