Eligibility:

Purchasers must not include the name of anyone under the age of 18 on the ticket due to the requirements of the Public Trustee Act.

Tickets may only be purchased or sold in Alberta.

Contest guidelines prohibit the following people from purchasing tickets in the lottery: Executive members of the Covenant Foundation's Board of Trustees & Governors; employees of the Covenant Foundation, staff of Stride Management Corp, staff of Calder Bateman Communications Ltd.; and their immediate family members.

The Split 50 is a separate lottery Ticket Purchasers are not required to purchase a ticket in the Split 50 Lottery to be eligible to purchase tickets in the DreamLife Lottery. However; ticket purchasers who only purchase DreamLife Lottery tickets and not the Split 50 Lottery tickets will only be eligible for the DreamLife Lottery draw being held on November 9, 2018.

The 12 Days Lottery is a separate lottery. Ticket Purchasers are not required to purchase a ticket in the 12 Days Lottery to be eligible to purchase tickets in the DreamLife Lottery. The first Cash Bonus Draw will be held on Thursday, September 6, 2018, at Stride Management Corp., 3950 12 St. NE, Calgary, AB, starting at 11:00 AM. Only tickets received at the Lottery Ticket Sales Centre before Midnight on Thursday, August 16, 2018 will be eligible for this draw.

The Bonus Draw will be held on Thursday, September 20, 2018, at Stride Management Corp., 3950 12 St. NE, Calgary, AB, starting at 11:00 AM. Only tickets received at the Lottery Ticket Sales Centre before Midnight on Thursday, August 30, 2018, will be eligible for this draw.
